- \* A non-refundable retainer of \$30 is required to secure your time and date. If the session is cancelled the retainer fee is non-refundable and shall be considered liquidated damages to Wendy La Croix Portraits.
- \* Balance of promotion fee (\$20.00) is due the day of the session
- \* Cannot be combined with any other promotion
- \* In studio only (Ile Bizard, Quebec)
- \* A private proofing gallery of 10 images is provided in order to choose your final 2 images from
- \* Two final images of 1200 by 1800 px are included in this promotion. Files are optimized for web-display (72 ppi) and not print.
- \* One wardrobe change is permitted if time allows.
- \* Sessions are a maximum of 25 minutes beginning at the time the client reserved. A client arriving late reduces their time in studio.
- \* Rescheduling is subject to availability. In the case where there is no other availability based on promotion days specified, the client has the option to cancel and forfeit the retainer fee or keep the date and time originally booked.
- \* Additional images are available for purchase. Web files, 1200 by 1800 px (72 ppi) at the rate of \$25 per file and print resolution 2400 by 3000 px (300 ppi) (8"x10") at the rate of \$65 file.
- \* NO SHOWS - If the Client is more than 15 minutes late without contacting Wendy La Croix Portraits or fails to show at all, the Retainer fee is forfeited and shall be considered liquidated damages to Wendy La Croix Portraits. If the CLIENT wishes to reschedule the session after the no-show, the Client is required to pay a new RETAINER.
